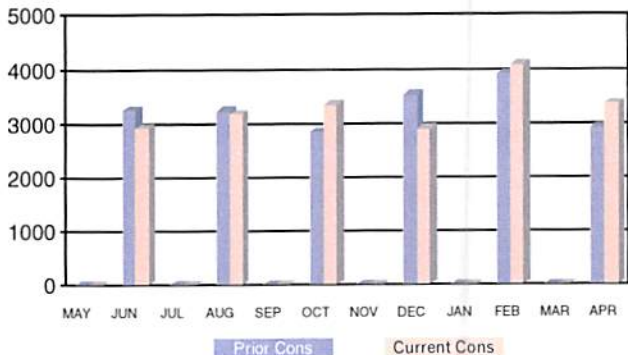
2020 Winter Averaging Rates are now in effect. Sewer charges may have increased or decreased based upon winter water consumption.
